## Background

Our member associations under the auspices of ENEP have created several Thematic Task forces. The recently created Thematic Task Force “Energy Platform” is run by FedEC, the Dutch Federation of Energy consultants, is a trade union of approximately 200 energy consultants in The Netherlands. The union takes care of the collective interests of its members.

Because Energy consultants can be seen as the lubrication oil between policy makers and industrial companies, added value can be created by a EU platform for energy consultants.

## What is ENEP proposing?

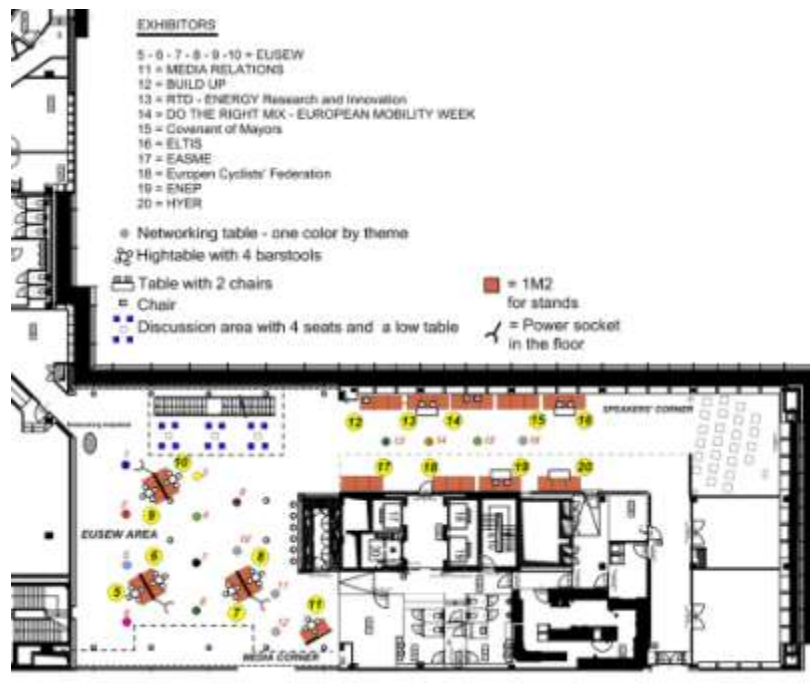
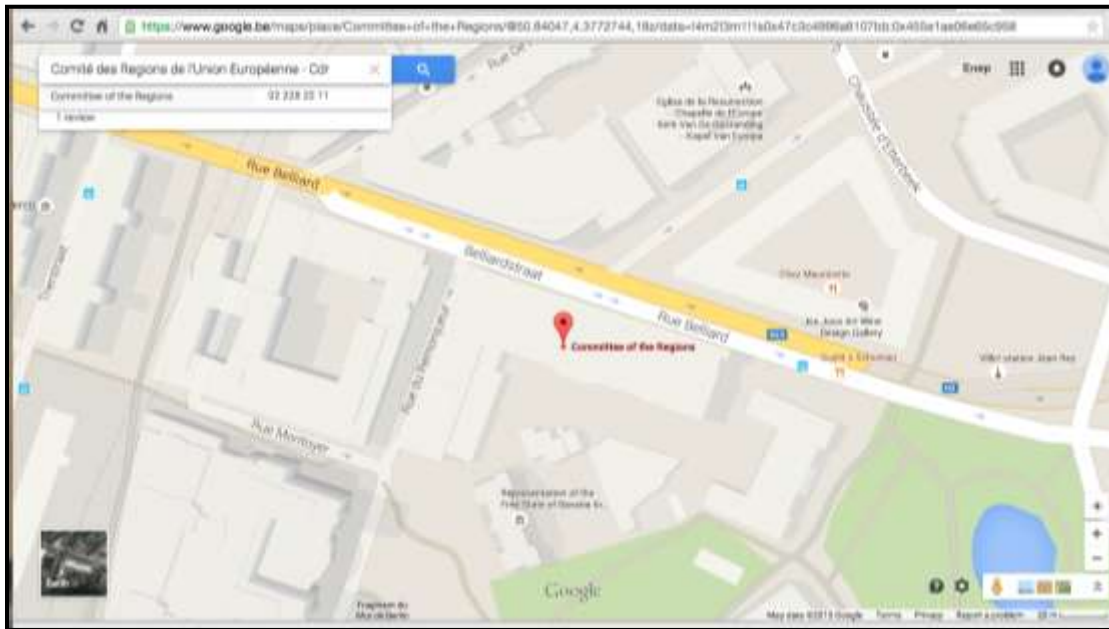
