Aims

- Act as a body to provide for consultation and cooperation on matters of public, professional, and academic interest concerning the environmental sciences and other environmental matters.
- Promote the study, coordination of education and research in environmental sciences, inspiring individuals to study, teach and support the discipline and ensuring that curriculums in further and higher education equip students with the skills they need for a career in the sector.
- Promote public interest, awareness and involvement in the problems of the environment including the causes, effects and the possible solutions to such problems. To liaise and co-operate with individual persons, national or international agencies or statutory authorities for the purpose of achieving the Objects.
- Promote dialogue and facilitate collaboration between public, civil and private society to deliver the Objects.
- Establish standards of competence and ethical codes of practice for those professionally concerned with environmental work, education or studies as a basis against which the public may judge what can be expected of individual professional members of the Institution and for members to know what standards of learning, competence and professional experience are expected of them.
- Disseminate information on all matters relating to the environmental sciences.
- Hold meetings and events as may be thought necessary or to further the Objects.

Membership

IES's turnover for the financial year ending 30th June 2018 was £382k. Expenditure was £364k. Income primarily comes from membership fees. There are approximately 4,150 members of the Institution (December 2018). The IES currently employs 7 members of staff and 3 contractors.

New Trustees

The IES is a registered charity which is governed by a board of trustees (called the Council). The Council members of the Institution of Environmental Sciences (IES) are its Trustees and Directors. The Council has overall responsibility for the work of the organisation, and has the following role:

- to oversee the charity's governance
- to determine strategy
- to performance manage the achievement of the strategy
- to approve the annual budget
- to monitor risks
- to contribute to the leadership of the charity

The Council is currently supported by the work of three committees: the Remuneration Committee; the Policy Committee; and the Fellowship Committee & Vice Presidents Panel

We are seeking trustees who can devote the time required to play their role effectively, with specific skills that can help us fulfil our charitable objectives. We are looking to add two Appointed Trustees:

- An individual with an understanding of **financial and risk management** and to act as the Honorary Treasurer
- An individual with an understanding of charity and/or employment law

Time Commitment

Appointed trustees are asked to commit eight days a year to the IES. This includes attending four Council meetings which are usually held at the IES offices in London. Meetings are hosted during the week and during working hours. Remote access options are available. In addition, there is usually one away day per annum. Between meetings, appointed trustees are expected to contribute electronically to office and Council discussions.

Appointed Trustees are appointed for a period of three years.



Specifications

All IES trustees should:

- Understand the role of the Trustee and be able to add value to the charity through expertise, counsel and sound judgement
- Understand competing pressures (financial, operational, personnel) involved in running a growing charity
- High intellectual capacity with the ability to distil complex information and bring a pragmatic approach to its application.
- Strong communication, networking and interpersonal skills
- An interest in the environment and a commitment to IES's charitable Object.

Specific skills

Either:

• Experience of preparing financial or management accounts as an accountant (financial or management) or through acting as a treasurer at board level

Or:

• Professional experience of charity and/or employment law as a lawyer or solicitor or through extensive experience at board level with other charities or through any non-executive director role.
