Subject: Amendments to the Levelling-up and Regeneration Bill

Dear Secretaries of State,

The Environmental Policy Forum (EPF) is a coalition of 13 professional bodies and learned societies representing around 70,000 environmental professionals across a variety of related disciplines. The views expressed in this letter are those of professionals, close to practice, duly qualified, and often working in industry, many running successful businesses.

On behalf of this extensive network of experts, we are writing to express our deep concerns regarding proposed amendments to the Levelling-up and Regeneration Bill, which would weaken the nutrient neutrality requirements for building new developments.

We wish to state our support for the <u>position of the Office for Environmental Protection (OEP)</u> in this matter. We are keen to emphasise the following three key points, which together represent our most significant areas of opposition to the proposed amendments:

i. A regression in law: The proposed amendments threaten objectives for water quality and the condition of protected wildlife sites, which amount to a regression in law. It's vital to note that this regression in law comes at a time of a decline in nature and a water quality crisis. As required by the Environment Act, this regression in law would require an admission that the Levelling up and Regeneration Bill would reduce the level of

environmental protection provided for by any existing environmental law. That it is not an amendment to the Environment Act seems irrelevant in terms of practical outcomes.

- ii. **Incoherent policy undermining delivery:** The proposed amendments reflect incoherent policy, as they undermine the delivery of various welcome government commitments and announcements notably:
 - The ambitious legally binding environmental targets as set out in the Environment Act 2021 (including halting the decline of species by 2030).
 - The Environmental Improvement Plan, with the proposed amendments meaning the public will pay for increased water pollution. This undermines the underlying commitment to the 'Polluter Pays' principle.
 - The Nutrient Mitigation Scheme for developers, announced earlier this year.
 - The UK's commitment to the Kunming-Montreal Global Biodiversity Framework, to protect at least 30 per cent of our land and sea for nature by 2030.

We feel strongly that unless a joined-up approach is taken across government policy, delivery of our environmental commitments – including those noted above – cannot be achieved.

iii. An urgent need to consult the experts: The proposed amendments have been tabled despite insufficient consultation with the experts – those with the knowledge and experience of delivering the current nutrient neutrality requirements. This lack of consultation is reflected in the clear opposition of the Office for Environmental Protection, the independent body the government established to hold it to account.

Unfortunately, increasingly limited scrutiny and impact assessment of environmental policy is not isolated to these proposed amendments. Notable examples include just a ten-day consultation window being given for the revised air quality strategy consultation, and no consultation took place at all on the interim targets in the government's environmental improvement plan.

We ask that the government refer to its own <u>Code of Practice on Consultation</u> in this case and engage with the views and concerns of the environmental professional community. The EPF stands ready to assist, provide further evidence for our arguments and, as always, are happy to discuss in greater detail.
