## **General Comments**

Environmental Protection Scotland welcomes the Draft Noise Action Plan for the Glasgow Agglomeration. We would like to commend the Glasgow Noise Working Group and SENSG for the work taken since the last round of mapping in identifying Noise Management Areas and Quiet Areas (as listed in the 2013 update of their Action Plan). EPS hope that this new draft plan is supported by sufficient resources to implement the proposed actions listed in Section 5.6.

We note noise is embedded within the Local Transport Strategy and we hope that noise continues to play an important part of Glasgow's City Plan. Similarly we hope that local authority and Scottish Government colleagues working on this action plan work closely with air quality colleagues with the aim of integrating and developing both sets of action plans.

Environmental Protection Scotland would like to congratulate the Working Group and SENSG for producing another set of clear, concise strategic noise maps from a multitude of data.

We would like to see both SENSG and the Working Group to proactively communicate this information to the public so that they are aware of what is happening in their region and to ensure that action planning is widely understood by the public.
